Accreditation Meeting

Standard IIC: Student Learning Programs: Library and Learning Support Services May 24, 2010

Discussion:

The meeting covered Standard 2.C.1.c (Access): The institution provides students and personnel responsible for student learning programs and services adequate access to the library and other learning support services, regardless of their location or means of delivery.

Committee members reviewed items discussed in May 21 Accreditation Standard II Committee meeting. Judi McAlpin is the Standard II.C point person. A template for writing the self study was handed out in meeting. (Mary has copy) A suggestion was made to create a spread sheet to keep track of evidence. Mary will work on this. While gathering evidence this spring, committees can come up with a "wish list" of evidence that currently does not exist. The timeline for the self study is: First written draft is due at end of Fall Quarter (submit to Judi McAlpin); the final draft is due the eighth week of Winter Quarter. In response to a question Mary asked at the meeting, on Friday.

committee members discussed whether it was our committee's responsibility to assess other learning support services on campus. It was agreed that in the context of this self study, this committee has the ability and time to assess only the Library/LRC service area (refers to last evidence listed below).

Committee members reviewed the evidence listed for the standard.

Hours data for 2005-current

listed separately within one document on service hours. Summer session hours should also be

included. This may be the area to comment on short staffing and unexpected absences resulting in certain areas needing to be closed.
