News & Announcements:

- ❖ The following courses were approved on March 15th for Foothill GE for 2016-17:
 - Area III, Natural Sciences - CHEM 9*
 - Area IV, Social & Behavioral Sciences - PSYC 40*
 - Area VII, Lifelong Learning - PSYC 49, SOC 19, SOC 40*
- ❖ **Associate Degree for Transfer (ADT):** The CCC approved the application for the Biology AS-T degree on March 15th, which will be sent to the FHDA Board of Trustees for approval at their April 4th meeting.
- ❖ **Foothill GE Update:** Please be aware of a slight modification being made to Foothill GE Area I, Humanities. Currently, the courses listed under Area I are categorized within two different sections, but going forward Area I will contain a single list of courses. The GE requirement for Area I does not change—students are only required to take one course to satisfy Area I. As always, we advise all faculty and staff to refer students to Counseling with any GE-related questions.
- ❖ **Courses Not Taught in Four Years:** As shared in the Communiqué from Feb. 23rd, a list of courses that have not been taught in four years was sent to Curriculum Reps. Per CCC policy, these courses are scheduled for deactivation for the 2016-17 catalog. Divisions were provided the opportunity to request an exemption, and the CCC reviewed the request forms at the March 15th meeting.
