- ❖ **Honors Course Offerings for 2016-18:** This quarter, Foothill college offered 17 honors courses—our highest number ever for a single quarter! In an effort to maintain that high level of offerings, and to better assist students and counselors in developing Ed Plans, the honors program created a proposed schedule of honors courses for 2016-18. Please consider the proposed schedule (available from your CCC Reps) when discussing your own plans, at the department and division level. The schedule also contains a list of desired honors courses that are frequently requested by students—if you are interested in developing an honors version of your course, please contact Bernie Day. Admission to some universities has never been more difficult, and honors courses will help make students' transcripts more competitive!
- ❖ **ADT in Elementary Teacher Education:** Counselors have reported demand from students who are interested in pursuing a career in teaching. Foothill does not currently offer a pathway for preparing future teachers, and faculty across campus have expressed interest in developing such a program. Bernie Day has researched the possibility of developing an ADT in Elementary Teacher Education (follow [this link](#) to see the template) and encourages interested faculty to contact her.
