Growth models for Enrollment	Christopher Dela Rosa & Bret Watson	<p>The district is projected to exit "hold harmless" funding status in 2025-26 due to improved enrollment numbers.</p> <ul style="list-style-type: none"> <li>• District projected to exit "hold harmless" funding in 2025-26, receiving \$195M vs \$192M hold harmless amount.</li> <li>• Future growth constrained - only 26 FTES growth funded for 2025-26.</li> <li>• Need to focus on strategic, moderate growth aligned with priorities.</li> </ul>
