The enrollment in the division as a whole has largely remained steady, and students graduating with a General Studies-Social Science degree has increased significantly. There is reason to expect that those numbers continue to remain steady going forward, given the transfer of many of our students to the UC and CSU systems.

One of the most interesting aspects of this degree is that more of the students are from non-white groups (particularly Latino/a and Asian) than the white population. Females far surpass males in the program, with the 2012-13 ratio 51 females to 20 males 72% versus 28%), which is significantly different from the campus ration (54% female to 46% male).
