- Ethnic Studies Graduation Requirement: In response to recent changes to Title 5 regulations, California Community Colleges must require completion of a transfer-level Ethnic Studies course as part of the graduation requirements for the associate degree, starting with the 2024-25 academic year. The following language was approved by CCC on February 13th and will go into effect with the 2024-25 catalog (summer 2024).
