This may include specialized training, formal education, advanced professional learning or active participation in college governance structures. a. Guided Pathways Update	<p>Scheduling and Guided Pathways</p> <p>Escoto reminded the body that we put into our Quality Focused Essay a need to address and improve how we schedule classes. In order to make pathways to degrees, transfer, and program completion easier for our students, synchronizing our scheduling efforts at the Program-level would make sense. Also, publishing schedules ahead of time throughout the year, may potentially be very helpful for our students.</p> <p>We tend to look at scheduling courses from a Divisional standpoint, and may not necessarily look to see how these courses connect to a broader program/degree/certificate level. How would our courses work for students at the Program level? Over the next few months, let’s come together across divisions and look at scheduling patterns.</p> <p>Comment: We should make it easier for students to get the courses they need for their program. b. Enrollment Initiatives	<p>Our administrators are working to make data-driven decisions in regards to enrollment.</p> <p>Going into Winter 2018, we were at an operating deficit of 2 million. We are up in our productivity, due to increased enrollment in Summer.</p> <p>Deans are being asked to look at a course's productivity at a college-level. For example, some lower-enrolled courses are being allowed to run, because even though they may not help productivity, they may be beneficial for overall FTES (Full-Time Equivalent Students). The more FTES we have as a college, the more funding we will receive from the state.</p>

Deans are using the calculator (created by David Ulate), making these decisions based on College-wide data.</p> <p>“Shoppers” is a term used to describe students that apply to Foothill, log into the MyPortal system, and start looking at the course schedule, but never actually register in a course.</p> <p>Highest number of students taking courses with us online while also enrolled at other universities are Cal Poly SLO, San José State University (among others).</p> <p>We are assessing which courses these students end up taking, and will then offer these courses more in Late Spring/Summer. Hiring decisions to bring on more PT faculty in these areas.</p>
<p>c. Apprenticeship Site Visit/Meeting</p>	<p>This past year, we voted to include an Apprenticeship seat on the Academic Senate. The distance between Foothill’s main campus and our apprenticeship programs can make it a hardship for our apprenticeship colleagues to join our senate meetings.</p> <p>Last Fall, The Senate officers went over to the Pipe Trades Center off Old Oakland Rd. in San Jose to meet with representatives of our Apprenticeship Programs. We are proposing holding an upcoming Senate meeting at this location. It was also mentioned that getting financial aid and attending both FH and DA can be a difficulty for students. Currently, students that want to take classes at both FH and DA, must register apply and register separately at each campus. ASFC President Danya Adib shared her experience, along with other students’ similar complaints of how difficult it is to add courses district wide. It was clarified that our separate application and registration procedures aren’t Banner requirements. If we wanted to, our district could simplify application and registration.
