

COLLEGE CURRICULUM COMMITTEE

(reported by Rachelle Campbell)

Last met on Tuesday, October 24th.

- Approved the Student Resource Center proposal to create its own curriculum committee, which includes DRC (Disability Resource Center) and FEI (Family Engagement Institute).
- During the discussion and approval of Stand Alone courses it was noted that the Stand Alone Form is for credit courses. The form will be updated to address noncredit courses and presented at the next CCC meeting.
- Approved the Landscape Technician certificate presented by the Horticulture Department.

Foothill resolution addressing the issue of the Bachelor Degree Requirements

Senate Officers will be meeting with the Apprenticeship Programs on Nov. 1st at the SJ Pipe Trades Training Center to get feedback on the three resolutions:

- *10.02 F17 Dialog and Collaboration on Apprenticeship Faculty Minimum Qualifications
- *17.03 F17 Application of Faculty Policies to Apprenticeship Instructors
- *17.04 F17 Local Senate Purview Over Placement of Apprenticeship Courses Within Disciplines

Discussed the following resolution:

- *14.01 F17 Allow Students to Repeat Substandard Grades at Other Regionally Accredited Institutions
- Foothill has a process that allows students to complete courses they received a substandard grade in at another institution. The course is identified as repeated on the student transcript.

- Did a deep dive into the curricular process for how a thought becomes a new course. Kristy Lisle facilitated a discussion where the process was sketched out; division level, involvement of CCC, the C3MS process, articulation, board of trustees, state involvement and catalog. This was a first step towards defining where the pain points are in the process in order to inform future discussions. It is important to note that all courses, credit, noncredit, CTE, apprenticeship, are on the same schedule at this point in time.
- Reminder that the Nov. 7th meeting was moved to Nov. 14th due to the IEPI Pathways Conference that both Curriculum Co-Chairs, Andrew LaManque and Rachelle Campbell will be attending. The Nov. 14th meeting will offer a professional development training,

conducted by Carolyn Holcroft, regarding evaluating stand-alone courses through an equity lens.
