		<ul style="list-style-type: none">• R&R just voted to utilize unspent B budget carryforward dollars unknown amount right now; will be looking at various areas for investment for Equity Plan 2.0.• Possibly faculty full-time hires, short term 3-5 years or funds for cushioning the SERP gap for faculty positions; should we ever identify any positions, it will still go through the faculty prioritization process.• Kathryn: clarification the faculty prioritization process is just once a year, are you talking about the 5 we have already identified.• Thuy: no, every year is a restart, so this is for next round, and this is for Equity focused hires. The current prioritization is done.• Kathy: I do not recall that the same thing just happened in the R&R meeting• We could potentially spend it on a position that is only slated to last two to three years so it would not be an ongoing faculty position just that it could be some grant funded position.			

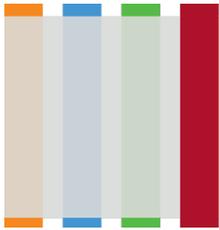

		<ul style="list-style-type: none">• Information is up on our Advisory page.• These are metrics identified by the Commission.• Not sure how the next iteration of goal setting in the direction from the state is going to look like, but something will be renewed.• Both the targets and the aspirational goals is part of our midterm report, which comes halfway during our seven-year accreditation cycle, and our report is due in October of 2021.• Part of this process is to also report back to the commissioner in terms of where we are in this annual process that we do for them.• The state sort of metrics may end in their current iteration, perhaps 2022, which is a great time to check in and see where we are at in thinking of the process of regular review for all our metrics. All these metrics have been approved by the board.• Initial targets and goals were set by the college, the			



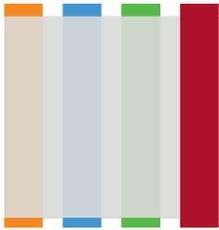

		<p>metrics were set by ACC as the actual data points.</p> <ul style="list-style-type: none">• There are six metrics, reported annually.• The measure themselves have been identified but the data shifts year to year.• Our target and aspirational goal have stayed the same.• We can have a conversation with our creditors to discuss what we mean by certificates and why we would want to change the way we choose to calculate.• With the addition of the cohorts in the dental hygiene program, we have awarded more bachelor's degrees.• The transfer one is calculated as the number transferred to a four-year institution based on the reported numbers from the UC, CSU and out-of-state system.• Kathryn: Thank you Elaine for the succinct presentation. 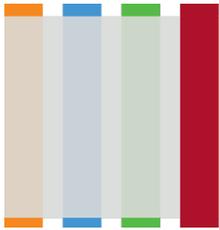

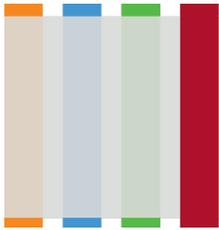

One of the focuses in program review has been to keep the data simpler at this point. Please have them use as many of the metrics that we already capture so we do not have to reproduce.• The guided pathways steering committee could help facilitate some of that conversation of what is core success.• Brian: I was not comfortable with the heavy focus on success rates as being the measure of how we are doing. A much easier way is to just kind of start passing people more frequently and you get higher success rates, so I was very uncomfortable with that the pressure it seemed to me on focusing on success rates especially overtime.• As we continue to get better at the process, and we implement program review is we need to increase some of the elements and fields that
