IEC vs MIPC role

- Align with MIPC evaluation
 - Participation
 - Communication
 - Decision-Making
- Recommendation - MIPC supports Blueprint 2030 implementation by:
 - College Engagement --> Participation
 - Information Awareness --> Communication Plan
 - Transparency --> Decision-Making (process of making and sharing out)
 - Other?

IEC vs Goal Stewards role

- Clarify the Goal Stewards' role and responsibilities
 - Activity planning/metrics feedback
 - Minimize duplication of resources
 - Identify resources requested
 - Problem solving
 - Meet w/objective team
 - Report out
 - MIPC
- Recommendation – Blueprint implementation support from Goal Stewards and IEC should be distinct?

What IEC could do

- Blueprint evaluation
 - Document implementation process
 - Provide iterative guidance to Blueprint Teams
 - Goal Stewards report to IEC
 - Report out to MIPC
 - Is this a summary or more substantial documentation?
 - Is this the only reporting line to MIPC about the Blueprint?

IEC's perspective and role: Alignment

- IEC documents progress
 - Scorecard
 - Measures change
 - Quantitative
- IEC discusses process
 - Evaluates meaningful change w/defined criteria
 - Qualitative

Blueprint 2030 Criteria

ALIGNMENT

Clearly connects goals, activities, and outcomes to priorities and institutional objectives.

[Goal Stewards and/or IEC?]

REFLECTION

Encourages reflection on progress, challenges, and shared insights across teams. This effort is conducted with a focus on continuous improvement.

INTEGRATED PLANNING

Connects objective outcomes to the college mission and values, including broader institutional planning aimed at improving student learning and achievement.

INSTITUTIONAL EFFECTIVENESS

Integrates effective practices into ongoing college processes.

Effectiveness: Improved outcomes based on identified metrics.

Sustainability: Improved outcomes endure beyond initial objective activities.

DATA AND METRICS

Leverages data and metrics to identify targets, monitor progress, and assess outcomes.

EQUITY-MINDED

Encourages thoughtful consideration of equity and student outcomes.
