

Housing

1. Housing needs to be studied further. Is it the mission of a community college? Other entities are addressing the issue.

Allied Health

1. No examples of joint projects between the two colleges
 - Allied Health Building to combine all the programs into one site
2. "I'm deeply concerned that health science programs are not directly listed on these spreadsheets & documents, whereas a number of other department facilities are noted specifically."
 - The health programs need more space to accommodate students, patients & updated medical-dental equipment.
 - The Dental Hygiene, Dental Assisting & Respiratory Therapy Programs have been at Foothill for over 50 years and are still in the same facilities, with only minor renovations.
 - Radiologic technology also has a long history and is struggling with facilities for instruction.
3. The health sciences programs (dental hygiene, dental assisting, rad tech, respiratory therapy, DMS) do not have adequate space for classroom, clinic and lab instruction.
 - The programs prepare students for jobs in the workforce
 - Dental Hygiene has been at the college for 60 years and is operating in the same space.
 - Only a few minor renovations over the years
 - A new health sciences building that meets HIPAA and all ADA requirements is critical for the workforce and provide dental hygiene care for our patients.

Observatory

1. Upgrade the observatory to also support automated observing, which would support astronomy classes (ie-students could plan observations, and work with resulting images), could open up further outreach opportunities. The three main areas of the upgrade would include:
 - Setup dome for computer controlled operations
 - Telescope for camera operations (new telescope as Peninsula Astronomical Society owns the current one)
 - Computer systems software for operations and data distribution
