KEY DEFINITIONS

FULLY VACCINATED

Person has completed a vaccine series (two doses of Pfizer or Moderna plus the booster shot, if eligible; only one shot for J&J, plus booster if eligible).

Headache; runny nose/congestion; sneezing; sore throat; new loss of taste or smell; fever or chills; cough; shortness of breath or difficulty breathing; fatigue; muscle or body aches; nausea or vomiting; diarrhea.

STUDENT SUBMITS VACCINATION **RECORDS TO THE COLLEGE**

STEP1

Student uploads proof of vaccination to Pyramed

Exemptions:

• Students submit religious exemption request to https://bit.ly/FHvaccine-religiousexempt. Students submit medical exemption via Pyramed

STEP 2

Foothill Student Health Services verifies submitted vaccination records and reviews medical exemption requests according to CDC guidelines.

Dean of Students Office reviews religious exemption requests.

STEP 3

Students will be notified within three work days if exemptions are granted.

STEP 4

Students who do not upload their vaccine information to Pyramed or provide proof of medical or religious exemption, will not be able to register for classes.

STEP 5

Exempted students are required to submit covid test results 72 hours before going to campus. Test results are uploaded to Pyramed and compliance is monitored by Student Health Services. Exempted students who fail to comply with the testing requirement, will be dropped from their in-person or hybrid courses.
