

## Governance Update

### Advisory Council:

#### Oct. 9

The Advisory Council had its first meeting of the year on 10/9. We received an update from Kristy Lisle on IP&B/Program Review, both in terms of the need of Advisory Council to hear the 19-20 presentations of the comprehensive program reviews that were delayed due to COVID in the spring, and also the ongoing work on preparing Student Services Program templates for the comprehensive reviews for this year. AC will hear the 19-20 presentations at a special meeting on the 10/30, and during our regular meeting on 11/6, and these presentations will take up those entire meetings. IP&B is continuing to meet to launch year 2, which included creating the new templates for student services program, and that work is nearly complete. A question/concern



was raised about the makeup of IP&B, as it was acknowledged that the only faculty rep now attending regularly is Academic Senate President, Kathryn Maurer.

We also heard a [presentation](#) on Accreditation from Elaine Kuo, Foothill's Accreditation Officer. We voted to approve an Accreditation Study Group, to be chaired by Elaine, to start work on the Mid-Term Report. We also voted to approve the [faculty prioritization process](#) for 20-21.

### **Revenue and Resources Council:**

#### **Oct. 16**

On 10/16/20, the R&R Council met for the second read of the Measure G bond priorities list. Council members and non-members raised questions and concerns about prioritization of such items as the Student and Faculty Support Center and KCI roof. There was also discussion about whether items could be moved up in the priority list if related to return to campus. Members voted to approve the bond priorities list with a few edits, which will be outlined in a memo to President Nguyen.

#### **Oct. 9**

The first meeting of the new school year of the R&R Council was held on 10/9. Student leaders shared two resolutions: one on gender neutral bathrooms and one about affordable housing. The Council confirmed its priority list for the year which included updates to the Facilities Master Plan, the Return to Campus Plan, as well as addressing the use of carry over funds for equity work. Two new Pharmacy Technician programs were presented (new pathways for dual enrollment, certifications, and licensure – the Basic Pharmacy Technician Certificate and the Pharmacy Assistant Certificate) which R&R fully supported. Bret Watson provided an update on the Facilities Master Plan and Measure G bond priorities list, as well as the need for a Return to Campus study group. Elias Regalado shared an update on the status of bookstore. Bret Watson provided an explanation on carryover funds in order to start the discussion on how we could use carryover funds to forward an equity agenda at the college. There will be a lot more discussion to come.

### **Combined Advisory and Revenue and Resources Councils:**

The joint councils hosted a Town Hall on 10/14 to review the [Guiding Principles for Budget Reduction](#), and Bret Watson's [Budget Reduction Proposal](#). There was minimal feedback from the Town Hall. The joint councils then met on Friday 10/16 and voted to approve the Budget Reduction Proposal, with the stipulation that if/when these cuts are required by the District, the joint councils would then be engaged to review and recommend how the \$2.35 million proposed cut to the B Budget would be shared by divisions and programs.

The joint councils are not planning on meeting again until January and/or if there is an emerging need arising related to budget reductions. Going forward President Nguyen has suggested that Advisory Council be dedicated to budget reduction conversations, and R&R stay focused on tasks associated with their work on the Facilities Master Plan, how to allocate carryover B Budget dollars that need to be spent, costs associated with potential Return to Campus plans, etc. The Advisory Council voted to re-establish a workgroup group, to be co-chaired by Academic and Classified Senates, to produce processes for program discontinuance.




