### (1) General Announcements & Reminders

The number of people who participated in the governance survey increased. 80 people filled out the governance survey last year compare to 93 people filled out the survey this year.

The governance retreat will be hosted at Sunnyvale Center on Thursday, September 14, 2017. President Thuy Nguyen hopes the retreat can become a tradition. The purpose of the retreat is the find the opportunity to improve the quality of governance. Another purpose is the follow through of the governance survey.

Enrollment always affects the budget, and Nguyen reminded the council should aware of this issue. Associate Vice President of Finance Bret Watson showed the Resident FTES Trend and 3 Year Restoration Analysis graph from the June 12, 2017 Board of Trustees Presentation. Nguyen explained the 3 Year Restoration Analysis is to capture the budget for 3 years. 3 years is the highest budget the school can capture. If the enrollment keeps going down, it will create a new base; therefore the college has to keep up the budget.

### (2) President's Report on new Foothill website and logo, FMP update

Marketing Director Andrea Hanstein presented the new Foothill logo and announced that the new website will launch in July. Hanstein foresees that a lot of existing documents have the original Foothill logo, so the Marketing office will support the transition.

Hanstein explained that the new logo is a flat design, which means minimum design and simplicity. The new logo keeps the main features of the original logo, such as the hut. Extra features can potentially be added to the new logo.

Denise Swett and Nazy Galoyan reported the results of the Early College Promise event on June 20. Swett reported that there were 60 students signed up for the program at Mountain View high school. Swett thanked Galoyan for organizing the event.

Nguyen presented certificates to PaRC council members who served at the meetings this past academic year and who are leaving the council next academic year.

The Facilities Master Plan (FMP) is approved. The items in the plan will be prioritized according to the importance of the service.

Carolyn Holcroft corrected part 5 of the minutes from June 7, 2017. She pointed out the program review was discussed at the Academic Senate meeting instead of the Faculty Association meeting.

Interim Associate Vice Principle of Finance Bret Watson reviewed the resources prioritization chart. The Vice Principle of Finance and OPC prioritized the items on the lists. The OPC resource allocation process for next academic year was discussed. Some council members concerned that what happen if certain resources appear next year but not yet approved for funding. Watson explained if it is the case, he will look at the B Budget carryover funds for each department, or any other available funds to cover the resources. Watson explained these will be onetime expenses.

Council member asked if there is a list of tips on how to cope with the new purchasing requirements as outlined in the Purchasing Authority Grid and Purchasing and Payment Grid. Watson answered that the council can refer to the Purchasing website or contact Purchasing department directly.

The Admin Council will discuss the Governance Survey results during the Admin Council retreat. Some of the highlights of the Governance Survey are:

- The administrators do not feel like their inputs are valued.
- There are only 11 administrators answered the survey, the number is far less than the number of faculty and staff who answered the survey.
- The council should look at the bigger picture of the survey results, because the college researcher only selected certain questions for the presentation, so the council should not conclude the results with these selected questions.
- Some administrators and staff do not realize the program review changes over time.

• The council should look at the survey results through a different lens; for the people who are not involved in governance, the council should let them know the program went through planning.
