BUILDING & GROUNDS REPORT – A. Stenger

LED SIGNAGE INSTALLATION

Proposed locations for new LED signs was presented. The first is to be installed in the lower campus on wall between Lohman Theatre and stairs. Two additional phases will include an LED in or near the Campus Center, one on the perimeter road near lot 3 and one in the new PSME area to be built.

ACTION: No objections - will be forward to Pres for approval

CAMPUS POSTING POLICY

Concerns raised by RT:

- Number of postings permissible are too few section 2 D&E
- Concern raised for impact on marketing to monitor ads that will go to LED and/or Fusion. It was pointed out that there is already a process in place to address that concern.
- Want B & G to make bulletin boards and kiosks high priority

- It was shared that the goal of this policy was to reduce the use of "paper" for advertising and to protect the campus from unsightly and damaging postings
- Also pointed out that we must balance that with ample opportunity for publicity for events
- Noted that round kiosks, similar to the ones at DeAnza, will be installed for display of paper posters, plus 5 additional bulletin boards to be installed
- Want assurance that these rules apply to outside groups such as "book buy back" that "papered" the campus with ground advertising they should be bound by same 10 poster regulations
- Need specific and ample guidelines for posting during ASFC elections

ACTION: Steve Anderson will send Annette wording for posting of ASFC election posters ACTION: requested that Posting Guidelines go to Classified & Academic Senates then returned to B & G

ACTION: all concerns will be shared with B & G committee.
