From interviewing students who attended they appreciated the help on days they could register. We used the enrollment dashboards to see the increase in enrollment for Fall and are still analyzing the Winter term events.

Additional analysis will need to be done now that the orientation is updated and we'll need to survey students who have completed it

The survey is done through Google Docs and a dashboard was created to monitor the feedback and results. Unfortunately with a low submission rate, the new plan is to publish the survey in more areas and post the QR code in the office.
