a. ETAC Issues – Willie Pritchard

Acting Chief Technology Officer, Willie Pritchard led a wide-ranging discussion on his proposal
for ETAC subcommittees. A motion unanimously passed to accept Pritchard's draft proposal,
excluding the third paragraph (suggesting no need for Senate confirmations) and including the
participation of students on committees. The Senate voted that ETAC retain two faculty members from each campus and that a one year term for faculty ETAC membership was too short.

b. Language Arts Proposal -

a. Technology and Distance Learning Issues -

- Other issues discussed included: the California Virtual Campus, adding to our ETUDES option, the Great Online Teachers seminar, specific course standards, student retention, intellectual property rights, appropriate faculty compensation, workload and planning issues, course evaluations, student guidance and placement, learner persistence and training for potential students and faculty.
