- ❖ **Activity Course Family Proposals:** The Kinesiology & Athletics faculty presented their revised "families" list. The CCC voted unanimously for approval, and thanked the KA faculty for their reconsideration after suggestions at the November 6th CCC meeting.

Please remember the general rule of thumb: a course (or sequence) should be marked as "equivalent" would essentially have mastered the same outcomes and objectives by taking the course at either campus. If you've misplaced them, your CCC rep can provide you with the detailed guidelines again. Please remember that you are also responsible for contacting the De Anza faculty for input, as well.
- ❖ **Substantial Course Changes for 2013-14:** The Prerequisite for CHEM 30A is being changed to MATH 217. Please remember to check your curriculum sheets, if you require CHEM 30A, the student must complete MATH 217 as well (or have tested out of the prereq).
