Fall 2015 to Fall 2016 Comparison

- Combined, F1/FZ and Other Visa category is down 126 or -8%.
- The decrease could be attributed to the decrease in F1/FZ visas. Total F1/FZ headcount is down by 150 or -13%.
- Total Other Visa (non-F1/FZ) headcount is up by 24 or 5%. J1 visa (exchange visitor) has the largest increase of students; it is up by 36 students or 86%.
