The SLO Primer: What's it All About?

Lots of acronyms in the air!
What do they all mean? Here's a chance to learn more about the important projects we're working on this year as we begin our development of student learning outcome assessment cycles. Let's start with the big picture and then focus in on the course level.

Institutional Student Learning Outcomes (4Cs)

First of all a context for our discussion: You'll remember that we developed some institutional outcomes for our 21st century students. We called them the 4Cs---critical thinking, computation, communication, and citizenship/global consciousness. These are the "habits of mind" that we help our students develop in all of our courses. And how do we know that our students have mastered these competencies?

....Here's FRAMES.

Foothill's Rubric Assessment Model for Evaluating SLOs is a series of criteria developed by

Beginning Wednesday, 12:00PM, November 12, join Rosemary Arca and colleagues for conversation about SLOs and PIE (purposeful intellectual exploration)! Join us every Wednesday until the end of the quarter. Bring your questions about writing SLOs, about matching outcomes with faculty. These rubrics can be applied across disciplines to describe student mastery of each of our institutional outcomes. In fact, the teams developing and piloting these rubrics are engaged in some great conversations about teaching and learning across the curriculum and you can join in.

And that brings us to **PROGRAM PLANNING.**

Now and Then! Now (actually this Winter) each program will develop one program SLO when it completes the Annual Update required this year. Then, each Division's programs will complete an extended Program Plan every five years. Both the Annual Update and the Program Planning documents will "inform" resource allocation and decision making.

As we focus in, we move to the course level and to **SLOACs.**

Each student learning outcome assessment cycle is a product of the instructors conversation

about the learning that takes place at the course level. The SLOAC cycle includes defining student learning outcomes, reflecting on the data gained from the assessments, and using the information to improve learning.

DARED

The method we're using to review our continual improvement of instruction as mandated by accreditation. This is a cycle of defining, assessing, reflecting, and enhancing learning in our courses, as well as documenting the entire process.

And that's about it. Granted, it's a little alphabet-soupy but it's also a process that demonstrates our commitment to deep learning and to our students' success at all levels of our college community.

Online Learning Update

Judy Baker is managing a Hewlettfunded grant project for 50% of her time during Fall and Winter quarters. With 50% backfill and an Innovation Grant, she's invested in four major projects and initiatives, including:

Online Course Quality: A project designed to address the quality of online courses, specifically student evaluation of online courses and compliance with Title 5 requirements for

documenting 'regular effective contact' between instructors and students in online courses, as well as to further build our learning community of online faculty that was started last year with regular meetings and the Etudes Course Showcase event.

Student ePortfolio (Innovations Grant Project): A project designed to support faculty and students who want to pilot-test the use of student ePortfolios as an alternative assessment tool. Low-enrollment Online Courses: A project designed to explore ways to promote our low enrollment online courses.

Use of Virtual and Home Science Labs in Online Courses: A research project that will collect information on this issue from faculty and literature. The final research report will be presented to the Curriculum Committee by the end of December.

College Skills & Basic Skills Initiative Update

Based on campus conversations last year we are renaming Basic Skills on campus to College Skills. Anything still called Basic Skills Initiative (BSI) pertains directly to some aspect of California's statewide basic skills initiative and funding.

We are in the process of putting together the College Skills Steering Committee to direct and implement the BSI Action Plan developed last year, as well as add new initiatives through research and staff development activities.

We filed our initial five-year BSI action plan with the State, and the steering committee will be developing related resource allocation planning for this year. Presuming our funding continues for 2009-2010, we will implement one for next year during Spring Quarter of 2009.

In addition to the steering committee, we will continue to

have College Skills Committee meetings. If you were on an BSI investigative team last year or your name is on the action plan, this is the place to be. Check out our Campus Skills website to see the conversations and recommendations that have happened and will continue to happen.
