The Instruction and Institutional Research Office has been tremendously busy this past month. We are aware that when WE are busy so are YOU! Our newly developed SLOAC reporting processes supported the tremendous work that you all accomplished in SLO writing (indeed, I have found many interesting SLOs and am now curious about what you find as a result of your assessments) and will be used to report the assessment reflection from appropriate faculty. Again, a shout out to all of you who did this work!

The **Program Planning Committee** is working to complete our faculty and staff friendly, but comprehensive, program review process that will undergird our new **Integrated Planning and Budget Processes** structure (the result of a Task Force of the same name).

The Educational Master and Strategic Planning Task Force has vetted the first draft of our potential Strategic Initiatives, as well as begun a review of our Mission, Vision, Values and Purpose Statements.

The **SLOAC committee** is designing a new website to meet the needs of multiple audiences: our accrediting body, our faculty and staff who need support and information to engage in SLOAC, and students. In addition, we are working to develop a set of assessment workshops to be launched in the Fall to support the "A" in SLOAC.

The College Skills Learning Community Team spent two days at a regional BSI meeting engaging in productive deliberations about how Foothill could provide, in large scale, the kind of small program attention that we know our students need to succeed. We expect next year to be a planning year for some new programs to support our students.

In **Curriculum**, we have been working to support the development of new Non-Credit courses and have provided several workshops to help with training faculty on these requirements. We have approved the Stand Alone Course Approval form, the Distance Education Approval form, the new General Education requirements (and, soon, we hope, the Breadth statement).

These are just a few notes to describe for you the scope of the work that we find ourselves performing. We hope that our efforts are ultimately supportive of your work at Foothill!

Brief History

The Honors Program is not new to Foothill College. Foothill College first experimented with honors classes in the Spring term, 1961. The program gained acceptance and evolved more fully in 1963 but did not become an official "Institute" until 1983.

Foothill currently offers twenty-four honors lecture courses and nearly forty 1 to 2-unit honors seminar courses. Some honors courses are offered as split classes (½ honors, ½ non-honors); however, this practice is decreasing. All new honors courses have either been approved or are under consideration by UC and CSU for articulation and inclusion on the IGETC and CSU GE certification lists, as appropriate. The Honors Institute currently identifies twenty-four honors faculty as serving students, in addition to several adjunct faculty.


Honors Institute Student Enrollment

Year Participants 2000-2001 75-100 2002-2003 125-150 2005-2006 200 2006-2007 325 2008-2009 450+


Honors Scholar Program Completers

Honors Institute participants who complete a program of six honors courses with a minimum cumulative GPA of 3.3 are recognized as Honors Scholars. They receive a scholarship as well as a permanent transcript notation, in addition to recognition at Foothill Commencement. The number of honors scholars is increasing, as evidenced below.



UCLA Transfer Alliance Program (TAP)

Foothill has been approved for the UCLA TAP program since 1999. This program offers preferred admission to the UCLA College of Letters and Science for Honors Scholars. The Foothill honors student (TAP) acceptance rate to UCLA is between 91 and 100% (typically 95-98%). For Fall 2009, 72 students were certified for this program, an all-time high. Foothill has more students transfer to UCLA than to any other UC campus.



Stanford University Community College Honors Research Symposium

The 2nd annual Community College Honors Research Symposium was held at Stanford University on Friday, April 17. Mary Lou Heslet and Bernie Day served on the planning committee for the event, which attracted more than 220 students from across California. More than 110 proposals were received for approximately 60 presentations. Eleven Foothill students were selected to present their research. Some of the other Foothill community members attending the event included Teresa De La Cruz, Fatima Jinnah, Konnilyn Feig, Scott Lankford, Simon Pennington, and Charlotte Thunen. All faculty and staff are welcome to attend. The next symposium will be held at UC Berkeley in April, 2010.


Sustaining the Excellence and Enthusiam: A Workshop on Efficient Assessment and Effective Conservation of Teacher Energy

College Curriculum Committee Update

The College Curriculum Committee (CCC) has completed the remaining three General Education (GE) patterns: Natural Sciences, United States Cultures & Communities, and Lifelong Learning. At this point, the Senate has ratified the GE patterns and the CCC is hard at work on the last GE task, which is to finalize revisions of the GE breadth statement. The moratorium on applying for new courses to one of the GE patterns should be lifted before the end of the quarter. The CCC has also recently finalized the form that faculty will use to document regular and effective contact in distance education courses. Like the GE patterns, this too has been ratified by Senate is available for use.
