Articulation & Honors Update by Bernie Day

Foothill students continue to transfer to baccalaureate-granting institutions in impressive numbers. Our June 15 **Transfer Celebration** attracted approximately 200 transfer students and their guests. The event provided students transferring fall 2011 with an opportunity to meet other students who will be attending either the same university or other colleges and universities in the region. Because the majority of students do not obtain an associate degree prior to transfer, this was a joyful opportunity to celebrate the completion of their rigorous lower-division major preparation and general education coursework. Transfer Degree Update

In response to recent legislation (SB 1440)-known as the **Student Transfer Achievement Reform Act** (STAR), the Foothill College Curriculum Committee recently approved the creation of two new transfer degrees. Congratulations to both the **psychology and sociology departments** for developing Foothill's first AA-T (Associate of Arts-Transfer) degrees in Psychology and Sociology. After recently securing local approval, the degree applications will be sent to the California Community College Chancellor Office for approval.

Foothill faculty from the following departments are in varying stages of development on transfer degrees: mathematics, communication, business, history, and kinesiology. Additional Transfer Model Curriculum templates are available in the following disciplines: Administration of Justice, Early Childhood Education, Geology, Physics, Political Science, Studio Arts, and Theatre Arts. It is expected that finalized **Transfer Model Curriculum** will soon be available in Biology, Chemistry and English.

Under the provisions of the new law, the California State University will grant **priority admission** into a similar baccalaureate degree program with a guaranteed junior status to students who complete the AA-T and meet all prescribed admission requirements; however, the provisions of this law do not guarantee a student admission to a particular campus. Community college transfer to the California State University has declined dramatically in the past few years, primarily because of the lack of spring admission opportunities.
